BOARDnetWORK is a fully managed service created especially for Nonprofits Insurance Alliance members.

This customized, web-based resource is a flexible and feature-rich communication tool that will help streamline governance activities while improving the board's function.

## Customized User Homepage

- Points out newly added information every time you log in
- Shows upcoming board and committee meetings
- Provides meeting agendas and documents
- Access to the board roster
- Access to many other corporate documents and additional resources

## Calendar

- One click on an upcoming meeting opens the entire meeting agenda in HTML format
- Each meeting document is posted inside the agenda
- System automatically creates online PDF format of each document
- Download or print the entire board book with a single click
- Choose from a 12-month or one-month calendar view
- Directors can sync meetings and events to their personal calendars

### Document Management

- Four specialized document centers to house important information:
