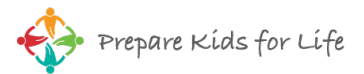

RE: In strong support of AB 2496 (The Foster Family Agency Accountability Act)

The commercial insurance market has rarely been kind to nonprofit organizations. 35 years ago, nonprofits came together to solve many of the insurance problems facing us. Despite our successes, changes in the judicial system have made it more challenging to insure certain nonprofits. These changes have even paralyzed some nonprofit sectors, such as foster family agencies (FFAs), to the point of being uninsurable.

FFAs are nonprofit organizations licensed by the Community Care Licensing Division of the California State Department of Social Services to engage in the recruiting, approving, training of, and providing professional support to, certified parent(s); or in finding homes for placement of children for temporary or permanent care who require that level of care as an alternative to a group home.

We are standing in solidarity with our fellow 501(c)(3) nonprofit foster family agencies. Despite 12,000 of us coming together to solve our collective insurance difficulties with our own state-authorized, nonprofit risk pool,

Nonprofits Insurance Alliance of California (NIAC), FFAs face imminent loss of their insurance due to judicial processes beyond their control.

Nonprofits provide essential services to our communities. From food banks, to homeless shelters, to affordable housing, to care of children and seniors, nonprofits provide many mandated government services in a cost-effective and efficient manner. This includes the foster family agency system.

As nonprofits, we understand our responsibility to the clients we serve. We understand that nothing in AB 2496 will prevent injured foster children from recovering damages from responsible parties — nor should it!

We support AB 2496 and urge you to support it as well. Please ensure that FFAs can continue to do their important work for California's children.
